## NOTICE TO EXHIBITORS

*This match is held under American Kennel Club rules.*

- **January 1, 2009 Obedience Regulations, Chapter 1, Section 3:** Jump Heights required with entry. Include Jump Height on entry form with class. Entries without Jump Height will be judged at the end of the class.
- **Jump Heights** will be in Ascending Order
- **Qualifying Score** Required for All Ribbons/Rosettes
- **No entry shall be made and no entry shall be accepted** which specifies any condition as to acceptance. Entries will not be accepted without fees, signatures, or the "Agreement" that accompanies the Official AKC entry form.
- **This club does not agree** to arbitrate claims as set forth on the Official AKC entry form for this event.
- **Changes, additions, or corrections** to entry forms must be received in writing prior to the close of entries. Changes received by telephone are not accepted.
- **Entries received** without fees will not be accepted.
- **Returned checks** do not constitute a valid entry fee. Entries accompanied by returned checks will be charged an additional \$30 fee.
- **There is no refund for duplicate entries or overpayments.** The Match Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made.
- **Entry fee shall not be refunded** in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by the Match Committee. There is no refund of entry fee for bitches in season.
- **No entry fee will be refunded** if the match cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- **Exhibitors should follow their veterinarians'** recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- **Dogs may arrive at any time** prior to their scheduled time for judging, but not before opening Match hour of 6:00 P.M. After being judged, dogs not required for further judging may be excused.
- **Judges need not wait** for any dog holding up a class. Owners or their agents alone are responsible for the presence of their dogs in the judging rings.
- **Exhibitors are responsible to** pick up after their dog----no exceptions!
- **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Match Committee, be asked to leave the match site. In such case, no refund of any entry fee shall be made.
- **All dogs must be on leash** at all times except when in the ring for judging.
- **Dogs are allowed** in rings during judging only.
- **There shall be no drilling or intensive or abusive training** of dogs on the match grounds.
- **The Border Collie Club of Arizona and MLF Dog Sports**, officers and members, assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.
- **Ribbons will be awarded** in the ring to the person exhibiting the dog. No awards will be mailed.
- **Entry limited to Border Collies.**

**DO NOT LEAVE DOGS IN CLOSED VEHICLES!!** All persons attending this dog show hereby waive any claim for damages against MLF Dog Sports or anyone associated with Border Collie Club of AZ in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

### CLASS RESTRICTIONS

As per AKC Match Regulations, Chapter 2, Section 1:

"No dog with the CDX title may compete in any Regular Class at an OA or OB Sanctioned Match except Utility. Such dogs may be entered and participate in the Open B Class, but may not compete for any awards in that class".

As per AKC Match Regulations, Chapter 2, Section 1:

"No dog with the UD title may compete in any Regular Class at an OA or OB Sanctioned Match. Dogs with the UD title may be entered and participate in the Open B or Utility Classes, but may not compete for any awards in these classes".

***Obedience and Rally entries will be arranged and judged in ascending jump height order in all classes where jumps are used.***
